Procedure Summary

Texas A&M University-Corpus Christi (TAMU-CC) maintains an Emergency Operations Plan (see Appendix) to properly protect university personnel and property in an emergency. This plan includes hurricane/tropical storm defense.

Procedure

1. EMERGENCY OPERATIONS PLAN

1.1. The Emergency Operations Plan's general objectives are to:

- (a) Protect and preserve human life and health;
- (b) Minimize loss or damage to the university's facilities and resources;
- (c) Ensure appropriate communications and notifications within the university, the community, and beyond;
- (d) Elicit a response which is appropriate to the magnitude of the emergency;
- (e) Establish a core team of well-trained individuals capable of committing resources;
- (f) Maintain an Emergency Operations Center (EOC) and provide guidance for operating an emergency command post site;
- (g) Describe EOC operations to include staffing and responsibilities;
- (h) Keep the public informed of the status of emergency operations in a timely manner; and
- (i) Emphasize the practice of safety concepts during emergencies, recovery, and restoration.

1.2. The scope of the Emergency Operations Plan is limited to:

- (a) Emergencies that may occur at facilities owned or operated by TAMU-CC;

- (b) Emergencies that require the assistance of an internal department(s) and/or emergency responders outside of TAMU-CC; and
 - (c) Activities that commence from the first indication of an emergency condition and continue until the end of the incident when normal operations are resumed.
 - 1.3. Because of the proximity of the university to the Texas Gulf Coast, TAMU-CC will maintain a hurricane/tropical storm defense plan as part of the Emergency Operations Plan to safeguard students, faculty, and staff and protect campus property in the event of a hurricane or tropical storm. The plan will cover responsibilities and courses of action for students, faculty, and staff throughout the hurricane season.
2. REVIEW AND MONITORING
- 2.1. The university's Emergency Operations Plan will be reviewed and updated annually by the Director of Environmental, Health and Safety. The updated plan will be reviewed and approved by the Incident Commander, Deputy Incident Commander, and President (if not serving as the Incident Commander or Deputy Incident Commander).
 - 2.2. All members of the Incident Command Team, as defined in the Emergency Operations Plan, are required to complete National Incident Management System training from FEMA. On a periodic basis, the Incident Commander and/or Deputy Incident Commander will conduct drills and table-top exercises to ensure familiarity with the university's Emergency Operations Plan.
 - 2.3. In accordance with Texas Education Code 51.218, the university will notify university employees and students of emergencies via Code Blue.
